21 December 2020 - Pronouncement of the Verdict in the #HalleTrial

Demonstration in Front of the Regional Court in Magdeburg

In the summer of 2020, the legal process against the far-right assassin of Halle began. On October 9 2019, he attacked the synagogue and the kebab shop Kiez-Döner in Halle (Saale) out of anti-Semitic, racist and anti-feminist motives and murdered Jana Lange and Kevin Schwarze. The over 50 people who were in the synagogue barely escaped the assassin. During his escape, the assassin injured several people, some of them seriously, on Magdeburger Strasse in Halle and in Wiedersdorf near Landsberg.

After 25 days of trial, it will now come to an end. The court case will be concluded with the pronouncement of the verdict, but there can and must not be a final stroke, neither in dealing with the attack itself nor in dealing with right-wing, neo-fascist violence in general.

As on the other days of the trial, on its last day there will be a large rally at the regional court in Magdeburg, creating a space of solidarity with the survivors, bereaved and joint plaintiffs of the rightwing attack, but also a space for critical questioning and illumination of the social conditions, state structures, and media reporting in the context of right-wing violence.

From a legal perspective, the court's primary concern during the trial was the individual guilt of the accused. The guilt has been proven; he has neither denied nor regretted his actions. It is to be expected that he will be sentenced to life imprisonment. Nevertheless, quite a few questions remain unanswered: How can Aftax I. and Ismet Tekin receive legal justice in case the attacks on them don't get recognized as attempted murders? Why do experts

and journalists know far more about the extreme right and their online activities than the police investigators do? Which findings can be taken from the trial and transferred to an investigation outside the court? What political and social consequences were actually drawn from the attack, its consequences and the trial? Which political actors can now be called upon to follow words of sympathy and shock with deeds? What ideas and desires do the bereaved and those who survived the attack have for dealing with the events and for further investigation? And what needs do they have in terms of compensation and appropriate remembrance?

These and many other questions will be addressed in the rally on December 21 at the regional court in Magdeburg. The focus will be on the perspectives of the affected persons and joint plaintiffs. We also want to create a space for the remembrance of Jana Lange and Kevin Schwarze. In addition, experts who accompanied the trial will draw conclusions.

The Halle attack does not stand alone. On the contrary, it is part of a political continuity of right-wing violence. A short time later, in February 2020, the attack in Halle was followed by the racist attack in Hanau, in which 10 people were murdered. Fascistic, anti-Semitic, racist and anti-feminist attitudes are widespread far into the so-called middle of this society. The assassin of Halle put into action what not so few people seem to think in this country. These are no single cases – they are not individual perpetrators! Join the rally on December 21 and make a mark: Solidarity with the victims - no stage for the perpetrator!

On the day of the sentencing we want to take solidarity on the streets with you! Because for us, the end of the trial does not mean the end of the confrontation with the assassination and the society that made it possible.
